BASIS FOR INVOKING COURT'S JURISDICTION

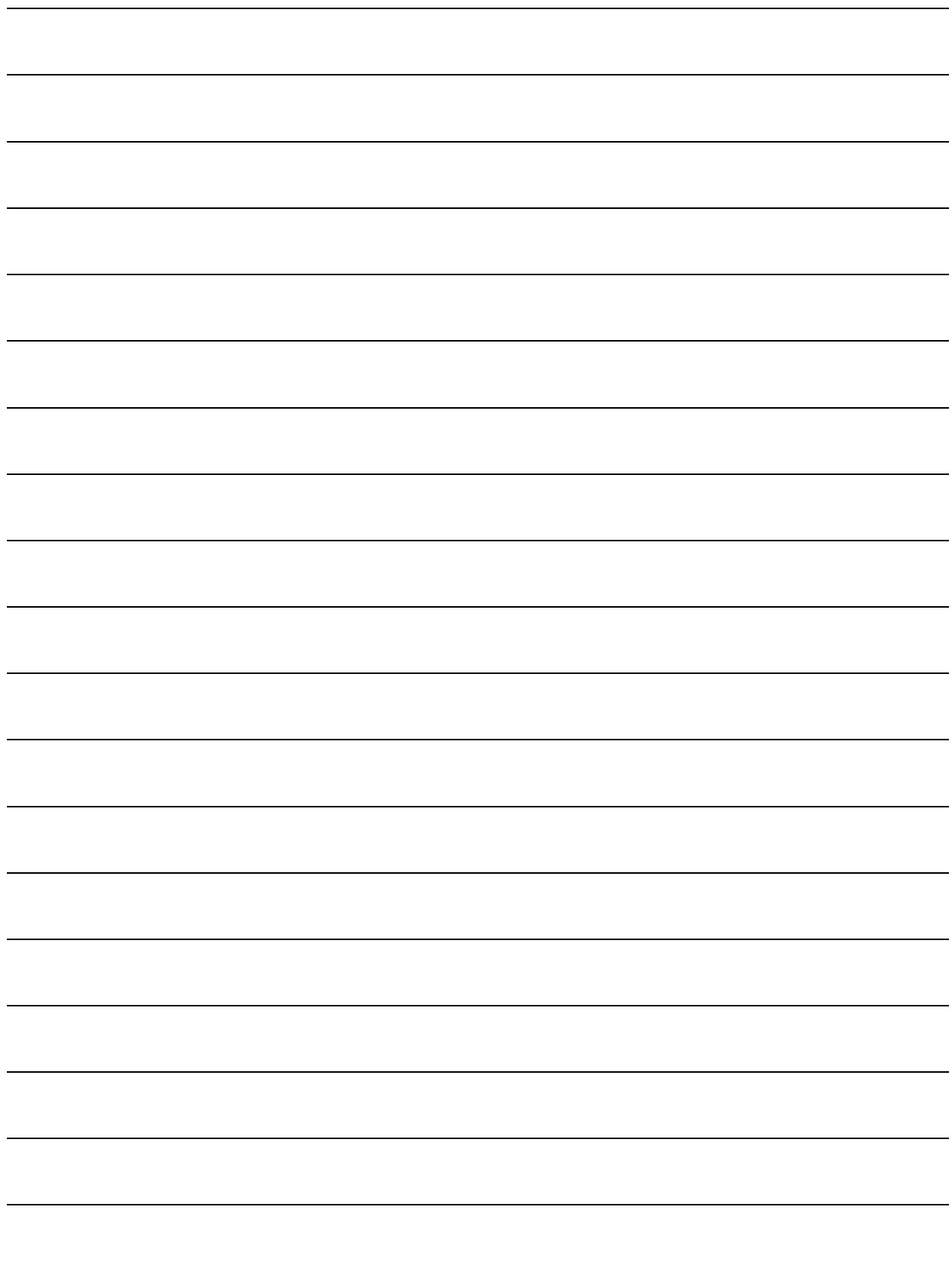
This Court does have common law jurisdiction to issue the requested writ
